1. **Harvard Advisory Energy Committee on behalf of the Town of Harvard** - replacement of streetlights in the Harvard Common Historic District – David Fay. **On hold**
2. **6 Littleton Road – Kelsey Hoontis:** Add asphalt “apron” to driveway – insubstantial change already established at prior meeting so no need for a hearing. Just need to vote on it at a subsequent meeting. The application was reviewed including photographs of the area where the apron is to be installed. Motion is made and voted on to approve application with Steve and George abstaining but all others voting yes including Marijke as an alternate.

ON-GOING BUSINESS:

1. Chair asks Wendy about efforts to involve inspector in HHC process. She reported that the inspector was looking into updating their online procedures to notify the commission when requests were made to install heat pumps (although she also points out that other outdoor equipment should be included). Wendy indicated that the inspector promised to follow up in about a week. The inspector is invested in helping nip these issues. The chair reiterates that the goal is not to prevent work from being performed but just to minimize impact, etc. The chair also notes the wide variation in the responses of various towns to this challenge with some providing clear guidelines and some doing nothing about it. Steve notes that HVAC might be a better, more generic, term than "heat pump" which is overly specific. Terminology that includes generators may be appropriate.
2. Chair asks Steve to follow up with Julie to get information for homeowners posted on web site. Chair reiterates request for commissioners to find additional resources to add to collection.
3. Chair indicates that letter was sent to district addressing some of these issues in an effort to educate owners and reduce issues with noncompliance. The chair suggests following up to confirm that letters were received (over 100 sent according to Pam).
4. Demolition delay bylaw – the chair presented a 2020 presentation regarding demolition delay bylaws. The chair asks if everyone is interested in continuing to pursue this. The verbal consensus was that we should continue to do so.
5. Training session – first one to go over rules. Scheduling discussion to follow via email.
