WHAT CHANGES REQUIRE THE APPROVAL OF THE HISTORICAL COMMISSION?

In Historic Districts, if you wish to modify any part of your property that is visible from a public way, you must first get the approval of the Harvard Historical Commission (HHC). Alterations include changing windows and doors, changing a paint color, new additions, demolitions, new fences, new paved walkways, new steps, and adding solar panels. Approval is not required for any repairs, repainting the same color, interior changes or landscaping. For a complete list see the Harvard Historic District bylaw (Chap 48) or the HHC Design Guidelines on the HHC website. You may also ask for an HHC Advocate who will be

No doubt you have received John's email regarding the necessity for this application. I'm not sure why we need to submit more than I did. Plot plan? Really? This fence is not a change but a reconstruction of the existing. Nevertheless I will supply you with a plot plan and photos of the old fence and the new one. I'll take these photos up to

Town Hall in an envelope and give to town clerk. The material is still wood and no, we don't plan to paint as the previous was unpainted. You will notice that the color is different only insofar as new wood looks different from weathered wood. Can't help that. If you look closely and who would but an abutter....you'll notice that the fence installers made a mistake, substituting a picket section for a large panel. I have notified the fence installers (Sudbury Cedar) that this needs to be fixed as we're in the town's Historic District and the fence needs to be identical to previous. They promise to fix this and won't be paid until they do. But not sure about timing as they need to order the material, supply chain delays, etc.

I hope this information is sufficient and that you can relay this info to the commission.

Perhaps it would be a good idea to remind homeowners in the Historic District of your rules by sending out in the mail all the regulations, maybe even yearly. I'm wondering if you expect us to get your permission to repaint our house white. This has never been an issue in the past.

Hello Faye,

I located your application at Town Hall; I'm not sure why the Assessor's office took it in since it's a Town Clerk submission. That said, I looked at it and gave it to the Town Clerk.

I'd like to ask that you beef up the application ahead of submitting it for review at a HHC meeting. The application should be more than one page and I'd like to see some of the following items included in it:

- 1. Plot plan identify where on the property the fence that was changed is located.
- 2. **Materials** perhaps you can find a picture of the types of wood fences that you installed so that the Commissioners see the product. It would be sufficient to find a picture online or simply to take a picture of the two types that were replaced.
- 3. Finished Product if they are going to be painted, then when and what color?

I can review your application once you do these things and then we can bring it to a subsequent HHC meeting. Be prepared that some Commissioners might ask why you did the work ahead of time.
