- 1. First Herb House brush clearing (PM) Pam emailed Tim Kilhart and work has not begun on the clearing. They are waiting for the large trees to be taken down.
- 2. Bromfield wall rebuild (PM) Marie suggests a diagram with an arrow (or highlighting) indicating the location of the wall to be restored. Do we agree? This goes out next week on COMMBUYS and to the vendor list as well as the concrete & masonry folks who've taken out bid packages for other jobs in town.
- 3. Historical District signs (PM) Tim Kilhart's boys have replaced the new signs at the Town Hall and at Bromfield House.
- 4. Historic District signage rules (ML) There is a town regulation for signs already. A special ATM in mid October is the deadline for any proposal for the warrant. HHC could put sign regulations in the Design Guidelines. Criteria such as location and height among others would be noted. Manny will draft "sign regulations". Pam will ask Joe Theriault for a word doc of the Design Guidelines.

- a. Daria reported on her discussion with Ken about the recommended procedure to change the bylaw for the historic district. We will plan on how to word the warrant article on exempting school buildings from HHC purview. Ben will talk to Tim about how to phrase the warrant.
