REVIEW/APPROVE MINUTES OF LAST MEETING:

Minutes were accepted for the February meeting. The vote was unanimous.

**NEW APPLICATIONS:** 

- 1. Guthro Fence application: David ran the meeting for the fence application. Neighbors asked that he survey the land. The repair will be 40' ft of existing fence and an extension. It was voted to be substantial. The vote was unanimous.
- 2. Sevigny Driveway/Hardscape application: Mark will be resurfacing his driveway, rebuilding an existing stone wall and creating a new patio. The vote was unanimous for a substantial application.

### **ON-GOING APPLICATIONS:**

#### **NEW BUSINESS:**

1. School Building Committee Presentation

Linda Dwight spoke to the group describing the project saying that the idea is to make the project one that is compatible with the rest of the district. Wade asked about the driveway, where would it go? There was a question about the location of the administrative offices. Debbie questioned the size of the solar array and commented that the building looks like an army barracks. Fred had a question about the routing of the bus traffic.

2. Town Warrant question as to a rework for the map of the district and clarification of school buildings in historic districts: There was a discussion about clarification of the current historical district map. We could ask selectmen to put forth a warrant to exclude the school buildings or HHC could submit a warrant with same or with including school buildings in the district. The current interpretation is not totally clear. A motion was made and approved unanimously to ask Ken to ask others to help us create a warrant article.

#### **ON-GOING BUSINESS:**

- 1. Town Center Sidewalks material (BG) The commission voted on the material for sidewalks. The choices were asphalt or concrete. Concrete was chosen by all but Steve.
- 2. Bromfield wall rebuild (EL) The repair and construction of 80' of the wall has been completed. The company submitted a payment request. They offered to finish the next section of the wall, approximately 40', at the same rate as the original bid. It came up as more than we had in the account so S&R Campos is refining their bid.
