CALL TO ORDER:

REVIEW/APPROVE MINUTES OF LAST MEETING:

The minutes of the November 4, 2020 meeting were approved by unanimous vote.

ONGOING APPLICATION:

3 Fairbank Street – Pat Hatch – Generator

Pat Hatch presented her application to install a generator next to her house. This was discussed at the last meeting and determined to be an insubstantial change. Pat stated that the generator will be placed near the house on the Littleton Road side, she plans to screen the generator with landscaping. When asked about the placement, Pat stated that she has no property in the rear of her house and that there are no possible locations where it would not be visible to some extent. Commissioners discussed and considered that the generator is not attached to the structure, is removable, and would be screened as much as possible. The application was unanimously approved as appropriate (Steve and George did not abstain as the possible conflict was not an issue).

1. 101 South Shaker Road – Charlotte Vallaey – new fence

Charlotte Vallaey presented

Charlotte presented her application to extend her agricultural fence utilizing the current design of wood post framing backed by a tall wire fence to keep out wildlife. She maintained that the construction was consistent with historic pictures of Shaker designed fences.

favor of the fence saying that it was in keeping with the Shaker district and was an attractive addition.

Commissioners' Deliberation and Vote

The commissioners discussed the fence. Manny thought it was in keeping with the district. George felt it did not distract from the landscape and the shaker properties nearby. Richard felt it was consistent with the design guidelines. Steve agreed. The commissioners voted unanimously to approve the application as appropriate.

2. South Shaker Road – Alice Thayer – fence

Lucas Thayer presented the application

Lucas showed the pictures of the current fence that encloses the garden area. It is comprised of metal dog kennel panels that are 10 by 6 feet in size. His first proposal is to leave the fence as is, his second to paint the panels green.

Public comments in favor:

Paul Willard felt that there should be no restrictions on agricultural fencing regardless of whether it is in the historic district.

Public comments against:

Stephen Morris, Karen Levitt, Andrea Polick, Spencer Marks, Rosie Vandorf and Judy Warner all spoke in opposition to the application. The consistent comments mentioned that the fence was not in keeping with the district, was an eyesore, and obtrusive. Judy added that she is pro-agriculture but the materials and appearance of this fence are inappropriate.

Public Participation closed

Commissioners' Deliberation and Vote

Manny pointed out that the fence is inconsistent with the design guidelines. George mentioned that the HHC's charge is to determine whether the structure (here a fence) is appropriate for the district, not to evaluate the purpose of the structure. Matt pointed out that the HHC favors agriculture and would approve a fence that is in line with the design guidelines. Pam stated that she had met with the applicants and asked them to consider alternate fences but they declined to do so. She thought the painted version was slightly better but still not appropriate. George agreed with the feedback from the abutters that the fence was distracting from the landscape and structures in the vicinity. The application was denied in its entirety by unanimous vote. The applicants were encouraged to work with Pam as their advocate to come up with an alternate design.

3. 20 Fairbank – Matthew McRae – modified front entryway, addition of 3 windows, modified roof line

Matthew McRae presented

Matt presented his application which had been reviewed at the last meeting. He shared with the

commission a history of the structure and his findings as he has renovated the interior. It seems that the original structure on this site is the house on the south side dating from the about the 1840's. The structure on the north side (which is the subject of this application) is likely comprised of two structures that were moved to the site and "stitched" together. They have no foundation or basement and sit on a dirt base. The lean to in the back is an additional structure. Matt reviewed each of the changes in the application including the addition of a window on the façade of the house over the entry way, improving the entry way to be more in line with a entryway from the period that will also help to shed water, the addition of two gas lamps, two windows on the side of the lean to and changing the roof pitch to both accommodate building code and preserve the interior beams which are original to the structures. Matt pointed out that because the renovation is so extensive he must bring the structure up to modern building code provisions.

Commissioners' Deliberation and Vote

Manny asked about the choice of casement rather than double hung windows on the side of the structure. Matt said these were selected because they would be above kitchen counters. Brandon appreciated the work that went into the application and Matt's summary of the history which was very helpful. George has acted as Matt's advocate and stated that buildings evolve over their lifespan and that Matt has worked very hard to preserve as much as possible in a structure that had significant condition issues. While the HHC might not normally approve a change to the façade of a historic structure, in this case the structure represents a number of periods and designs and is comprised of a number of structures so the change seems appropriate. He also pointed out that the preservation of the historic windows represented a significant investment of time and energy and the use of a historic window for the "new" window was commendable. Pam was impressed with Matt's efforts. Richard agreed and found Matt's efforts to be laudable. The commissioners voted unanimously to approve the application as appropriate in its entirety (Matt abstained).
