- Jim A brought up a situation that had occurred on the walk, when one participant decided they shouldn't continue and should return to the beginning. This elderly participant had been on the walk with her daughter, and the daughter agreed with her mother turning back, but wanted to continue on the walk herself and let the mother return to the start alone. Jim A expressed reservations about having a weaker participant separate from the group, but had acquiesced and the mother had gone off, apparently with no ill consequences. However, we concluded that should we encounter such a situation again (there have been similar scenarios with slight variations on two previous walks), we will try if possible to have someone accompany the separating participant.
