This hearing is for a Special Permit filed on behalf of George Carvill for an accessory apartment use at 216 Old Littleton Road, Harvard.

George Carvill was present to explain he was seeking to obtain all required permits necessary to validate the home he purchased several years ago as a five-bedroom dwelling. Mr. Carvill stated when he purchased the property the dwelling already an apartment established within it.

The members reviewed the requirements and documentation provided as detailed under Chapter 125-18.1.

Judith Gustafson, an abutter, expressed concern with existing exterior lighting, but had no objection to a Special Permit for the accessory apartment. After a brief discussion about the use of the property and the exterior lighting, Mr. Carvill agreed to make the necessary adjustments to the exterior lights.

With no further questions or comments, Steve Moeser made a motion to close the evidentiary portion of the hearing. Orville Dodson seconded the motion. The vote was unanimously in favor of the motion.

Members briefly discussed and agreed upon the following conditions:

- 1. The accessory apartment shall be limited to the area detailed on page 2 of 2 of the Floor Plan and marked as "FINAL PLAN".
- 2. The accessory apartment shall be limited to no more than two residents.

Steve Moeser made a motion to close the hearing and issue a Special Permit to include the above mentioned conditions. In addition, the Chair of the ZBA is authorized to sign the final decision on behalf of the Board. Orville Dodson seconded the motion. The vote was unanimously in favor of the motion.
